York's Israel & Golda Koschitzky Centre for Jewish Studies is deeply saddened to share news of the passing of our longtime colleague, friend, and inspiration, Irving Abella. His absence leaves an unfillable moral and intellectual hole in Canada, in Canada's Jewish community, in York's faculty, Department of History, Centre for Jewish Studies, and—most gapingly—for his friends and family. We send our condolences to the mourners and to all those who lives he touched.

I have the honour and privilege of serving as Professor Abella's first successor in the J. Richard Shiff Chair for the Study of Canadian Jewry, a position established at York University in 1997. Two years ago, I wrote An Appreciation for Professor Abella on the occasion of his 80th birthday (<https://www.thej.ca/2020/07/12/irving-abella-at-eighty-an-appreciation/>). They were words sweet to share in July 2020; I'm sharing them today, slightly rewritten, with distinct bittersweetness. Professor Emeritus Irving Abella, the historian, writer, teacher, and leader who served at an impressive array of both Jewish and academic organizations, died July 3 at age 82.

When he was made a member of the Order of Canada in 1993, the Government noted: "His writings and lectures have helped us to appreciate the rich and diverse roots of our country and broadened our understanding of the contributions generations of immigrants have made to Canada." He was elected as a Fellow to the Royal Society of Canada the following year and was recognized

with both a Queen Elizabeth II Golden Jubilee Metal in 2002 and with a Louis Rosenberg Distinguished Service Award by the Association for Canadian Jewish Studies in 2006.

A belated Shana Tovah to all! I hope that your new year has begun sweetly.



## Message du président



Chers ami.es,

We invite the community to join us for the virtual launch of the **"Hear Our Voices: Survivors Share their Stories of Trauma and Hate"** project on November 24, 2022, at 7:00 pm EST.

Hear Our Voices is a bilingual online course that foregrounds the voices of Holocaust survivors to educate students about the Holocaust and antisemitism. This launch will inform educators about the free bilingual resources that they can use in their own teaching, choosing from five thematic modules (Oral History, Antisemitism and Racism, Religion and Culture, Gender and Sexuality and Memory.) Produced by a team of Canadian researchers at Carleton University, resources include new oral histories, archival interviews, original mini-lectures, guest lectures by international scholars, digitized maps, timelines and interactive content, scholarly readings, archival documents, photographs and film.

In 1972 she and her family moved to Israel's Weizmann Institute of Science where she headed the PR Department for 25 years. Ricky has published six collections of poetry in English, including *Laissez-Passer*: Poems 2001-2009 and *Word Sonnets* for Corona Times, and two in Hebrew, *Mekurkaat* and *Miklat*. Her work has appeared in numerous publications and received a number of international awards.



**Morty Schiff** taught Mathematics and Creative Writing over many years at The College of Staten Island (CUNY), and squeezed in writing poems when the spirit spoke. He's lived in, and has been nurtured by, Montreal where he was born; Paris; New York; and Metuchen, New Jersey, where he presently resides with his wife and daughters. He was included in Raymond Souster's anthology of mid-century, *Poets 56: Ten Younger English Canadians*. His selected poems, *A Taste*, was published in 2013.



**Seymour Mayne** is the author, editor, or translator of more than seventy books. His latest collections include *Cusp: Word Sonnets* (Ronald P. 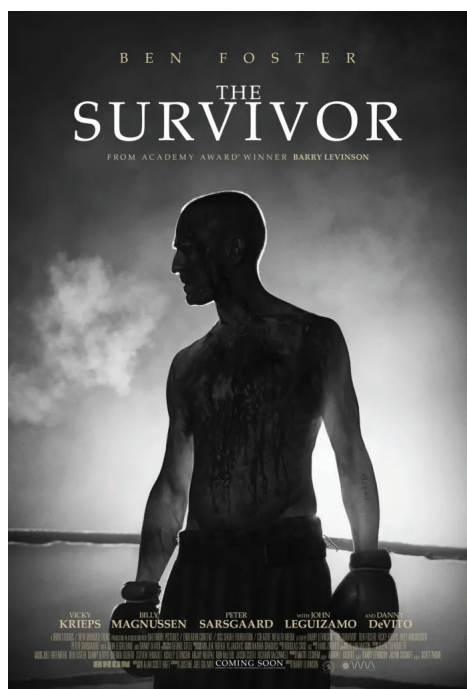

The virtual Launch Event for Holocaust Education Month 2022 will commemorate Kristallnacht, the Night of Broken Glass, which marked the violent turning point in state-sponsored attacks on the Jews of Germany, Austria and Czechoslovakia. The event will feature the distinguished and award-winning Holocaust historian Dr. Wendy Lower. She will discuss the research that led to her latest book, *The Ravine: A Family, A Photograph, A Holocaust Massacre Revealed*. By investigating a single photograph taken in Miropol, Ukraine, in 1941, Dr. Lower unveils the networks of complicity that made the Holocaust possible.

An overview of Ukraine and the Shoah will be delivered by Professor Jan Grabowski, history professor at the University of Ottawa.

Len Bennett is passionate about Israel and all societies striving to be liberal democracies. He hates bullies like the United Nations. He is also a news junkie and follows unfolding political and cultural stories all over the world, then shares his thoughts with editors at relevant media everywhere. And the editors have listened. What emerges is a deep understanding of the Arab-Israeli conflict from 1988 to present day. The book is a 30-year retrospective.

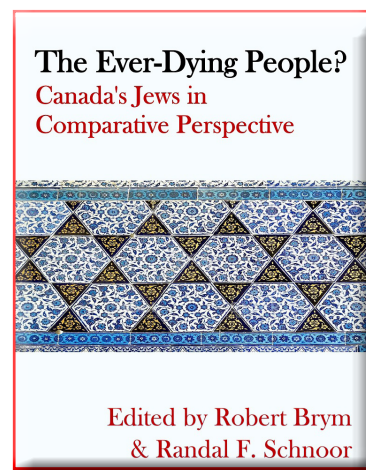

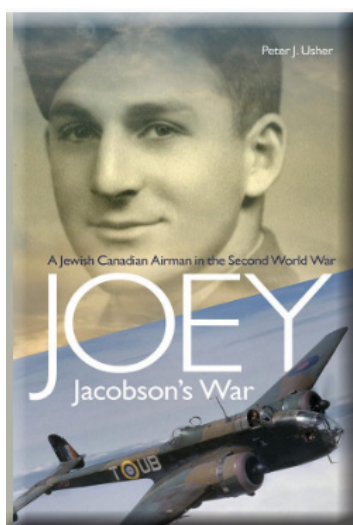

### SEYMOUR MAYNE

“The Word Sonnet: A Distillation

A Conversation between Author Seymour Mayne and Editor and Translator María Laura Sporturno”

Seymour Mayne published an interview article setting out the background and poetics of the word sonnet, the new sub-genre for which he is recognized as the leading international

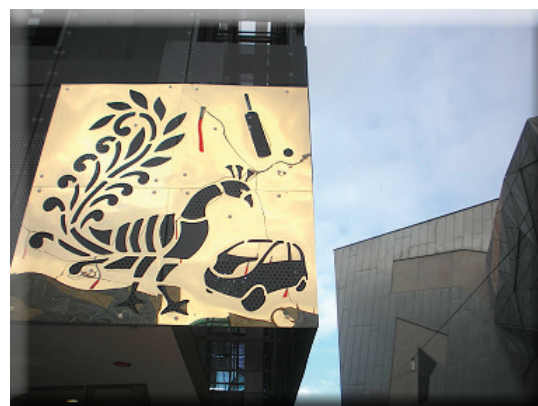

practitioner and innovator.

In a dialogue with his Argentinean editor and chief translator Prof. Mayne presents the history and characteristics of the word sonnet. The article also includes a selection of word sonnets given in various languages rendered by his translators. The word sonnets appended are in the original English, and also French, Portuguese, Spanish, Italian, Turkish, and Russian versions.

(The publication date given is December 31 but the issue was delayed and was uploaded only recently.)

## Transcendent Transnationalism? Jewish History and Heritage Across Time and Space

*Call for Contributions to Volume 8 of the Yearbook of Transnational History

Although originated thousands of years ago from historical Israel and Judah, the Jewish people today are an ethnoreligious group and a nation that transcends physical borders and is spread throughout the world. Connected by faith, ethnicity, and culture, Jews possess a unique collective identity. The Jewish peoples are a universal phenomenon with a distinct story of multiculturalism, diversity, and constant renewal.

Jewish history and heritage can be found in tangible places and objects as well as intangible heritage such as shared practices, common themes, materials, and ideas. Jewish history and heritage manifest themselves in different ways, crossing over time spans and bearing numerous tangible and intangible connections. Jewish history and heritage are often not limited by national borders and, like the people they represent, connected as a Diaspora.

Crossing over time and borders, Jewish history and heritage include themes that appear and disappear, layers of rituals and a combination of identities. They suggest changes over time and space. Therefore, Jewish history and heritage suggest a discussion unbounded by national concepts and theories crossing over time and spatial boundaries.

This means that instead of dealing with a particular issue of a given nation, experts in the field of Jewish studies are encouraged and obliged to engage in international debates and discussions that address understanding this heritage and these ideas. These frameworks focus on vast and various aspects.

The objective of this volume is to discuss these issues through case studies and original research of Jewish issues from around the world, from various cultural and geographic settings. We welcome articles from academics, professionals, and advanced graduate students based upon a broad range of Jewish studies approaches. Topics might relate to one of the following topics:

1. Conflicts or connections between Jewish monuments and sub features of Jewish history and heritage with local cultures and sites over the globe (e.g., the influences of specific Jewish features and characteristics and local cultures as manifested in art and architecture)
2. Layers of Jewish history and heritage across time – changes and preserved Jewish features (e.g., development of symbols and structures)
3. Common intangible rituals versus unorthodox traditions (e.g., practice & living heritage, different interpretations ...)
4. How do "others" view Jewish history and heritage (e.g., antisemitism and responses to antisemitism, Judaism as a culture in the diaspora and in Israel)
5. Travels of Jewish history and heritage (e.g., Judaism moving with immigrants from one country to another, from Israel to the Diaspora and from the Diaspora to Israel).
6. Historiographical engagements
7. Recent academic trends (e.g., decolonizing the Bible, colonial histories, land and resources)

Interested contributors should submit a 250-500 word proposal abstract along with a short CV (2 pages maximum) by March 15, 2023, to Shelley-Anne Peleg ([shelleypeleg@gmail.com](mailto:shelleypeleg@gmail.com)) and Hernan Tesler-Mabé ([hteslerm@huron.uwo.ca](mailto:hteslerm@huron.uwo.ca)) with the subject line "Transcendent Transnationalism? Jewish History and Heritage Across Time and Space." Decisions on paper proposals will be made by April 15, 2023. Full papers (including Chicago style citations – endnotes and bibliography) should be between 5,000 to 10,000 words in length using American spelling, grammar, and punctuation conventions. Non-native English speakers should have their papers reviewed and edited by an English speaker prior to submission. Final paper drafts are due October 1, 2023. □

Because proposals undergo blind review, please do not include any personal, identifiable information in your proposal attachment. Instead, please indicate your name, affiliation, address, telephone number, and email address in the body of the email.

Paper proposals are due on **January 19, 2023**. After an anonymous peer-review process, presenters will be contacted by February 24.

Our hope is also that this will be our final exclusively online conference, so ably organized by our Conference Chair Jesse Toufexis.

Given the aforementioned strangeness over the past year, we have been a bit more limited in our activities. Nevertheless, over the past year we have been lucky to have many of our colleagues take up/ flesh out initiatives: - David Koffman and Simon-Pierre Lacasse who worked tirelessly on the journal - Adara Goldberg (w/ Shirley Brodt) continue to produce a magnificent journal - Valentina Gaddi and Alexandra Stankovich who in their collectif judeites series helped bring the work of graduate students to our attention - and Megan Hollinger who has worked diligently and tirelessly as our Membership Chair and Treasurer, helping us resolve many of the banking difficulties we were facing when she took over... - as well as all the many of you have faced this year with great courage and devotion to our field We have maintained our connections with new colleagues, whether in Australia (conference panel) and we are delighted that our colleagues from LAJSA are drawing nearer (Contemporary Jewry issue, forthcoming volume on Canada-Argentina in comparison, as well as shared research) Our membership numbers are holding firm(ish) despite this year as our Membership Chair Megan Hollinger will share. - Last year I said we were at an inflection point. I believe we still are, and we should continue to think of how to best position ACJS for years to come. Obviously, we cannot answer all of these needs right now but should begin to think of how to do some new things:

a. to continue to reflect (at macro level) what future of our discipline will look like - our field is evolving along with others and we must continue to reflect on this - i.e. connections with others around

the globe... - we will in coming weeks renewing our discussion with CSJS colleagues about how to conceive of Jewish Studies in Canada, confront antisemitism on campuses, etc. \*\*

I remain convinced that we must continue to focus on attracting students to field and ACJS (hope Alex and Valentina will do this but we must all work to encourage this...) \*\*\* Is ACJS structure a legacy of our ties to Congress and should it change?

b. moving ACJS offices to Ontario

- I will be moving our operations to Ontario if we have your support and we will be following up with this initiative by way of a motion to make a change to our by-laws

- As I am taking up a new position at Huron, it might make sense for me to bring the ACJS with me there, at least initially and then reconsider whether it should remain there or move elsewhere - in past, we have considered a rotating office structure, moving w/ presidency, but doing so might be complicated unless we remain in one province

c. Report: Journal by David Koffman and Jesse Toufexis

Volume 31, Spring 2021, <https://cjs.journals.yorku.ca/index.php/cjs/issue/view/2296>, included three feature articles, a sub-section edited by Jesse Toufexis on the theme of landscape with five contributions, an Archives Matter subsection on Landscape & Memory, edited by Janice Rosen with six contributions, a translation instalment (German to English and French), a reflection (by Harold Troper), and six book reviews.

Volume 32, fall 2021, <https://cjs.journals.yorku.ca/index.php/cjs/issue/archive>, a special issue on Holocaust literature in Canada, guest edited by Ruth Panofsky and Goldie Morgentaler, which included ten essays, a translation instalment (Yiddish to English and French), a reflection (by Pierre Anctil), and six book reviews. The special volume was promoted to a wider set of organizations than is customary, and was featured on a number of public intellectual outlets, including an ACJS, York University Koschitzky Centre for Jewish Studies, and Friends of Simon-Wiesenthal Centre for Holocaust Studies co-sponsored Zoom launch event, <https://www.youtube.com/watch?v=uJWrmCj4IEM>.

Volume 33, Spring 2022, <https://cjs.journals.yorku.ca/index.php/cjs/issue/view/2298>, will undergo a few minor copyediting tweaks before our standard promotional push is made.

The journal editorial team moved our

entire operation onto teams.

#### Finances

Since last June, the journal incurred a total of \$4,896.40 in expenses, including \$2,348.00 for volume 31 and \$2,548.40 for volume 32. Note that this figure is different from the treasurer's report, which compiles expenses for given years, and not between AGMs.

By comparison, the journal had spent \$7,627.12 in the previous year (from June 2020 to June 2021). The difference can be explained by a decision to delegate all printing and shipping costs to a print-on-demand service.

- Copyediting (Vol 32) \$540,00 23 July 2022
- Graphic design (Vol 32) \$1808,00 15 November 2021
- Copyediting (Vol 33) \$562,50 28 February 2022
- Translation (Vol 33) \$516,90 1 March 2022 Graphic Design (Vol 33) \$1469,00 Pending

Since making our latest volumes available to Kindle Direct Publishing in November 2021, we have sold 13 copies of Vol. 31 and 17 copies of Vol. 32. The total royalty earnings for these sales are \$15.99USD (until end of March 2022, last payment available). While this amount is negligible, keep in mind that the journal used to engulf nearly \$2,000 in the process of printing and shipping volumes to members. The savings described in the previous paragraph reflect the adoption of print-on-demand services.

We plan on uploading our entire collection to KDP to make it available to interested readers. There are no costs associated with this process.

SSHRC Grant

The journal received an Aid for Scholarly Journal award from SSHRC in March to offset costs and support innovative practices between spring 2022 and spring 2025. We will use this grant to pay our regular expenses – copy editing, graphic design, and translation. We will also offer modest remuneration to the managing and associate editors for their work on the journal. The editor in chief will receive no remuneration. The SSHRC ASJ grant will cover all expenses associated with the creation of 6 volumes over these three years.

In addition to regular journal expenses, the grant will allow us to pursue some additional experiments in advertising. These include:

1. Paid, targeted advertisements (mostly on social media; perhaps podcasts) to potentially interested readers and contributors;
2. Hiring a Social Media Officer to expand our presence on Facebook, LinkedIn, Twitter, and Instagram;
3. Hiring a Tik Tok Video Producer to work with contributors to the journal to create content that is linkable to the journal with accessible insights;

5. Creating fully hyperlinked endnotes for (at first some) journal articles, linking primary and secondary sources to archival, library, and other media sources or finding aids;
6. Optimizing back-end searchability and functionality of the OJS host with



York University Digital Librarians;

This grant will, of course, free up funds from the ACJS to use to advance its mission in other, to be brainstormed and agreed upon, ways.

#### Looking Ahead

The CJS/Ejc will promote Vol.33, notable for its double Translation instalment, and our first publication of MP4 audio files.

We expect to publish Vol.34 on schedule in fall 2022, which will include the first of hopefully many forum/roundtable multi-author contributions, in this case on Canadian Jewish poetry (featuring scholars and poets), edited by David Koffman and Adam Sol.

"This year the ACJS connected with the Collectif Judéités and specifically Alexandra Stankovitch (U de Sherbrooke) and Valentina Gaddi (U de Montreal) in helping to promote and fund the Collectif's 10-event conference-program: 'Cycle de Conférences 2021-2022 - Connexions.'

Each of the 10 online events featured one researcher - mostly PhD students and candidates - discussing their work in the broad field of Jewish studies followed by questions to the researcher. There were 1 or 2 conferences per month between November 2021 and May 2022.

The Programs Chair attempted to begin a similar online event-series run by ACJS. The intention was to interview one PhD Candidate per event about their research in an informal and friendly way, with questions such as, 'Did you learn anything unexpected or particularly exciting in your field research?' The program did not get off the ground, although it may be of interest to the Program Chair for 2022-2023.\*\*

## Conference Report

"Happy to see everyone as always. Conference planning went relatively smoothly, and we chose to do it online right off the bat even though we started planning pre-Omicron. That ended up being the wise move.

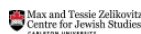

## 2022 Marcia Koven Award for Best Student Paper

The Association for Canadian Jewish Studies/ l'Association d'études juives canadiennes is pleased to announce Tyler Wentzell as the recipient of the 2022 Marcia Koven Award for Best Student Paper presented at the 2022 ACJS/AEJC Conference, held online May 29-31, 2022. Sean Remz and Emily Belmonte received honourable mention. This award is sponsored by friends and relatives of Marcia Koven and the Saint John Jewish Historical Museum (<http://jewishmuseumsj.com/>).

Marcia Koven was born in Saint John, NB, on December 26, 1926, and throughout her life devoted herself to the preservation and transmission of the history of the Canadian Jewish community. She was the founder of the Saint John Jewish Historical Society and the creator of the Saint John Jewish Historical Museum. She passed away March 4, 2022, in Ottawa.

### Winner of the 2022 Marcia Koven Award for Best Student Paper

Tyler Wentzell (University of Toronto): *'The Vanguard of the Vanguard of the Vanguard': Revolutionary Jewish Youth in Interwar Toronto, Montreal, and New York.*

Tyler Wentzell is a doctoral candidate at the University of Toronto Faculty of Law, a military historian and a serving infantry officer at



the Canadian Forces College and the 48th Highlanders of Canada. He is the author of *Not for King or Country: Edward Cecil-Smith, the Communist Party of Canada, and the Spanish Civil War* (Toronto: University of Toronto Press, 2020).

In honour of Women's History Month, Statistics Canada has published a podcast episode entitled **"Sylvia Ostry: Lessons From A Legend."**

Dr. Sylvia Ostry was appointed Canada's first and only female Chief Statistician in 1972, but she didn't get there by playing by the rules. She was ambitious but grew up in a world where many thought that it was shameful to be female and have a career.

Sylvia was a Jewish woman in economics, and even after she earned a Ph.D. from the University of Cambridge in 1954, she was denied a job with the United Nations because of her gender. Dr. Ostry was a researcher and professor at the University of Oxford and from 1979 to 1983 was the first female chief economist at the OECD, in Paris. She was the first-ever female deputy minister in Canadian history, was chairman of the Economic Council of Canada, and for eight years was the chair of what is now known as the Munk School of Global Affairs and Public Policy at the University of Toronto.

Sylvia's contributions were significant and led to 18 honorary degrees and awards, including one from the University of Waterloo and the Companion of the Order of Canada. The podcast goes behind the scenes to look at how she challenged herself to succeed, becoming both a respected economist and mother, and how she handled setbacks and discrimination, all while staying true to herself and demonstrating the integrity for which she is remembered today. □

Irving Abella's importance as a historian stands in its wide public reach, in its impeccable and incisive scholarship, and in the fact of his fellow historians' steady citations of his work from a wide range of Canadian and modern Jewish historical subject areas. He produced a prodigious body of scholarly writings in books, journal articles, print essays in public intellectual magazines, encyclopedias, newspaper editorials, interviews, and innumerable public and academic lectures around the world.

When I spoke with Dr. Abella shortly before his 80th birthday and asked him what accomplishment he was most proud of, he seemed unprepared; he hadn't been keeping track. After a moment of reflection, he told me that he was proud of creating the first course in Canadian Jewish studies to be taught at a university, in this case at Glendon College in the early 1970s. There were no books and few articles to read or assign; it was a field he himself would pioneer. There are now courses in Canadian Jewish studies from a variety of disciplines taught at close to a dozen universities across the country. Abella was among the first generation of professional scholars to take up Canadian Jewish subjects, and his writings and findings left an indelible print on the now-

mature and professionalized field. Alongside historians Jack Jedwab, Harold Troper, Richard Menkis, Robert Harney (1939-1989), and Gerald Tulchinsky, (1933-2017), sociologist Morton Weinfeld, and literature scholar Adam Fuerstenberg (1939-2016), Abella helped establish archives and the institutional structure for the field, brought new research techniques and questions, and advanced the early communal project established by Louis Rosenberg, David Rome, Sol Hayes, and

H. M. Caiserman. Canadian Jewish studies is now an integrated element in both the Canadian academy and the community of modern Jewish studies scholarship.

Canadian Jewish history was not the only field Abella pioneered. His first passion was Canadian Labour history, also in its professional infancy in Canada when he began graduate school at UC Berkeley and soon after at the University of Toronto, where he defended his dissertation, "The Struggle for Industrial Unionism

in Canada: the CIO, the Communist Party, and the Canadian Congress of Labour, 1936-1956" in 1969. His first monograph, *Nationalism, Communism, and Canadian Labour*, published in 1973, turned attention to the struggles for the rights of mostly immigrant working men and subjected the politics and organization of labour to rigorous historical scrutiny at a time when "important" Canadian history was considered the economic underpinnings of the nation – the fur trade, mining, the river barons, and the like.

His work on labour was influential among professional historians of Canada, and Abella was among the first to teach Labour History in Canada, again, with few books or scholarly resources at his disposal. Yet after three additional books and several articles in the emerging field, Abella's interest took a sharp, if clearly linked turn in the early 1980s, toward immigration, and particularly Jewish immigrant history. I asked him about the links between these two seemingly distinct phases of his scholarly life. The phases were indeed stark, he confessed. By the end of the 70s, he felt that the field had become "dominated by the ultra-left and anarchists", scholars who "demeaned the field." Though he continued to teach labour history through the 1990s, he had lost interest by the late 70s.

Abella was arguably the scholar with the largest imprint on Canadian Jewish studies. His monograph *None Is Too Many: Canada and the Jews of Europe*:

1933-1948, co-authored by Harold Troper, was a groundbreaking work about Canada's abysmal Jewish refugee policy in during and immediacy after WWII, a work that framed some of the key orientations of the field and impacted subsequent generations of historians of Canada and Canadian Jewish life.

*None Is Too Many* has been subject to continual, almost orthodox citation, considerable reflection and even some recent reassessment (a special issue of *Canadian Jewish Studies / Études juives canadiennes* in French and English, New Research on Canada and the Jews During the 1930-1940s was titled "None Is Too Many and Beyond / Au-delà du None Is Too Many" (<https://cjs.journals.yorku.ca/index.php/cjs/issue/view/2287>). Abella and Troper's work also influenced the civil service itself and remains oft-cited work for immigration reformers and progressives.

Abella contributed several other books on Canadian Jewish life, including *A Coat of Many Colours: Two Centuries of Jewish Life in Canada* (1999), and *Growing Up Jewish: Canadians Tell Their Own Stories* (with Edwin Goldman and Rosalie Sharp) in 1997.

Abella's leadership in the public history and Canadian Jewish civic sectors were impressive. He served as the director of the New Israel Fund, and editor of Middle East Focus.

He was the chairman of the Holocaust Documentation Project, as well as of the Canadian Jewish Congress International Affairs Committee; chairman of Canadian Jewish Congress National Archives Committee, and the Canadian Jewish Congress president from 1992 to 1995. He served as the President of the Canadian Historical Association (CHA) from 1999-2000.

When I asked him about the relationship between his scholarship and public leadership with respect to public history in Canada, and the Canadian Jewish community, he told me that his key motivation was the dissemination of historical knowledge. His presidential address to the CHA, published as *Jews, Human Rights, and the Making of Canada. New Series, Vol. 11 / Nouvelle série, vol. 11*, 3-15 in 2000, brought attention to profoundly important Jewish contributions to Canadian life to Canadian historians. Indeed, he helped forge the institutional grounding that has allowed for the continuance and flourishing of the field.

As president of Congress, Abella told me, he helped convince the Minister of Multiculturalism, Gerry Weiner,

to allocate a million-dollar multiculturalism research grant to Canadian Jewish studies between York University and Concordia University, investments that continue to bear fruit in producing new scholarship and teaching hundreds of Jewish and non-Jewish students at Concordia's Institute for Canadian Jewish Studies, and at York's Golda & Israel Koschitzky Centre for Jewish Studies.

Let us hope that Abella himself comes to be the subject of scholarly research down the line. Records that reveal the inner workings of some of his work can be found in the Canadian Jewish Archives Irving Abella Fonds, 1969-1991, and in the Irving Abella Collection at the Archives of Ontario, a collection consisting of oral history interviews he conducted in the early 1970s. We hope the balance of his records will one day reach an archive too.

We mourn the loss of our leader, teacher, and scholar. May his memory be for a blessing. **יידן רורב תמאה. □**

## Canadian Corporation for Studies in Religion Doctoral Research and Travel Scholarships

[The Canadian Corporation for Studies in Religion \(CCSR\)](#) is a consortium of learned societies and institutes including the Association for Canadian Jewish Studies, the Canadian Society for the Study of Religion, the Canadian Society for the Study of Islam and Muslims, the Canadian Society of Biblical Studies, the Canadian Society of Patristic Studies, the Canadian Theological Society, the Société québécoise pour l'étude de la religion, the Société canadienne de théologie and the Association catholique des études bibliques au Canada.

The primary purpose of the CCSR is to support the publication of scholarly research in the field of Religious Studies. Since its inception in 1971, the Corporation has published the journal *Studies in Religion / Sciences Religieuses*. It also supports the publication of three book series: *Matière à Pensée* (*Les Presses de l'Université de Montréal*), *Studies in Christianity and Judaism* and *Advancing Studies in Religion* (*McGill-Queen's University Press*).

### The CCSR Research and Travel Scholarships

The CCSR established a scholarship program in 2010 to mark the fortieth anniversary of its incorporation. The purpose of the scholarships is to enable advanced doctoral students and unemployed or underemployed graduates in the field of Religious Studies or Theology to conduct research and/or travel to conduct research that will contribute to their active research project and assist in building their research portfolio (e.g., research tools, necessary digital and print materials, research software, travel to archives, libraries, research centres, fieldwork locations). It is not intended for conference travel, travel to work with a particular professor, or for other networking activities.

The CCSR has allocated a total amount of \$7,500 CAN to be distributed among the successful applicants.

The scholarships are open to Canadian citizens, permanent residents of Canada and students on a study permit studying in Canada. To be eligible for consideration, applicants must be a member of one of the constituent societies of the CCSR and either:

- a) enrolled in a doctoral program and be studying an aspect of religious studies or theology, have successfully completed their comprehensive or major/minor field examinations, and have a thesis proposal that has been approved by their department or doctoral committee;
- or
- b) have completed an earned PhD in the field of religious studies or theology, but do not have stable work in the field of their doctoral research.

**To apply for the scholarship, please submit the following *as one single PDF file*:**

- A description of the proposed research, explaining its importance and contribution to the field (no more than two double-spaced pages); note that scholarship recipients must complete their travel or purchase their research-related materials by December 31, 2023.
- A detailed budget for the proposed research (costs of proposed materials or research tools, or travel costs such as air and ground transport, accommodation, per diem for meals and incidental expenses); list the amounts requested or obtained from other sources and indicate the amount of support requested from the CCSR to a maximum of \$2,500;
- A *curriculum vitae* (under- and unemployed) or transcripts of the applicant's master's and doctoral programs (students), providing evidence of adequate disciplinary tools: proof of proficiency in field work methods, required languages, etc.
- Proof of membership in one of the CCSR constituent societies

In addition, one confidential letter of support must be sent directly to the President of the CCSR at the email address above from either:

- a) the applicant's doctoral supervisor, including attestation that the applicant has successfully completed the comprehensive or major/minor field examinations and that the applicant's thesis proposal has been accepted by the department or committee  
or
- b) a senior faculty member familiar with the applicant's research, including attestation that the applicant does not have a permanent academic position.

The deadline for applications for the **2022 competition year is December 9, 2022.**

### The Adjudication Process

Applications will be reviewed and ranked by a committee of the Board of the CCSR consisting of three members, including at least one CCSR Executive member and one non-Executive CCSR Board member. The committee will rank the applications on the basis of:

- description of the proposed research travel or research materials (outcomes, importance to field, feasibility): 25%
- ability to complete the proposed research project (transcripts, curriculum vitae): 25%;
- detailed budget (relevance to the applicant's research stage, comprehensiveness and detail in budget): 25%;
- letter of support: 25%.

The committee will make its final decisions prior to its annual board meeting in January 2023 and publicly announce the results by February 1st, 2023.

Funds will be paid out upon submission of equipment receipts and travel expense claims in accordance with the financial policies and procedures of the CCSR; all expenses need to be incurred in 2023.





## **Corporation canadienne des sciences religieuses Bourses de déplacement et de recherche offertes aux doctorants**

[La Corporation canadienne des sciences religieuses \(CCSR\)](#) est un regroupement de plusieurs sociétés savantes du Canada dans divers domaines d'étude des religions : la Société canadienne pour l'étude de la religion, la Société canadienne des études bibliques, l'Association canadienne pour l'étude de l'islam et des musulmans et musulmanes, l'Association canadienne des études patristiques, l'Association d'études juives canadiennes, la Société théologique canadienne, la Société québécoise pour l'étude de la religion, la Société canadienne de théologie et l'Association Catholique des Études Bibliques au Canada.

La principale raison d'être de la CCSR est d'encourager la publication en sciences des religions. Depuis sa création en 1970, la Corporation publie *Studies in Religion / Sciences Religieuses*, ainsi que trois collections de livres.

### **Bourses de déplacement et de recherche offertes aux doctorants**

À l'occasion de son quarantième anniversaire, la CCSR a créé un programme de bourses destinées aux doctorants, afin d'encourager la formation de nouvelles générations de chercheurs en sciences des religions. Le programme vise à permettre aux doctorants dont la thèse est déjà bien engagée de procurer des matériaux de recherches ou de voyager, afin de mener les recherches nécessaires à leur travail. (Par exemple, pour acheter des matériaux, consulter des archives, les collections de certaines bibliothèques ou centres de recherche, ainsi que pour travailler sur le terrain.)

La CCSR a décidé qu'un montant total de 7 500 \$ CDN serait consacré aux récipiendaires. Chaque candidature pourra faire état de frais de 2 500\$ CDN. On encourage également les étudiants à présenter leur candidature pour des montants moins élevés.

La CCSR n'acceptera que les candidatures de citoyens canadiens et de résidents permanents, qu'ils étudient au Canada ou à l'étranger, ou d'étudiants avec permis d'études qui étudient au Canada. Pour être admissibles, les candidats doivent être inscrits à un programme de doctorat, étudier un aspect des sciences des religions ou de théologie, et avoir réussi leur examen de synthèse ou quelque autre forme d'évaluation sur le terrain. En outre, leur projet de thèse doit avoir été accepté par leur département ou le comité des études doctorales de celui-ci. Un récipiendaire de la bourse doit être ou devenir membre d'une des sociétés qui constituent la CCSR.

Les candidats doivent réunir un dossier qui comportera les documents suivants:

- Une description des matériaux et/ou du déplacement proposé, dans lequel le candidat exposera l'importance de ce voyage dans le cadre de sa thèse de doctorat et précisera le montant de l'aide qu'il souhaite obtenir de la CCSR. Le candidat doit y intégrer le montant des subventions sollicitées ou

obtenues auprès d'autres organismes. La CCSR valorise les efforts de financement conjoints.

### Évaluation des candidatures

Les candidatures seront évaluées et notées par un comité composé de membres du Conseil d'administration de la CCSR : présidente, secrétaire et membre sans désignation.
