2016 ACJS Conference: May 29-31, 2016

2016 CONFERENCE AND COMMUNITY DAY The Calgary Jewish community is very excited to host ACJS members for Community Day on May 29, 2016! Calgary has a small but very active Jewish community of roughly 8,000 and a vibrant history spanning the last 125 years. This year, Community Day will feature panels on Western Canadian Jewish history and the Montefiore Institute, the 1916 synagogue that originally served the homesteaders of the Montefiore farming colony in southeastern Alberta. The building, which will soon celebrate its 100th anniversary, was purchased



by a non-Jewish family in the 1930s and moved to a nearby town, where it was converted into the family home. It was moved to Heritage Park, Calgary's living history museum, and fully restored, opening to the public in 2009. The Community Day panels will be followed by a field trip to Heritage Park to see the "Little Synagogue on the Prairie" and a banquet celebrating the 40th anniversary of the ACJS. We are also discussing the possibility of a film screening and/or concert, with details to be announced. As always, the conference itself will explore a wide range of original scholarly research on Canadian Jewish history, life and culture.

COMMUNITY SHABBAT Local families will be opening their homes to ACJS members who would like to come early and spend Shabbat in Calgary! The registration form – which will be sent out



with the Call for Papers – allows members to indicate whether or not they need to stay in a kosher home and what they would like to do for Shabbat. If members would like to attend synagogue services, they are able to indicate which shul they would like to attend and whether they need to be within walking distance from it. Members will also have the option of having Shabbat dinner and then exploring Calgary the next day. We will match each ACJS member to a Calgary family who best fits his or her needs and preferences. There is no cost to take part in this program, and all ACJS members, regardless of religion or level of observance, are warmly invited to take part!

Promouvoir le champ des études juives canadiennes dans la francophonie canadienne

C'est face au déficit de chercheurs francophones dans le champ des études juives canadiennes que j'ai cherché à m'impliquer au sein de l'AÉJC. À la conférence de mai dernier à Ottawa, j'ai eu le plaisir de faire la connaissance d'une équipe dynamique.

Tel qu'entendu au terme des discussions tenues à l'assemblée générale annuelle, mon rôle est d'abord de rendre accessibles les activités de l'association aux locuteurs francophones du pays, dans l'espoir de créer des espaces d'échanges entre des chercheurs canadiens francophones et juifs anglophones.

Qui plus est, une communauté de chercheurs issus de la communauté sépharade et actifs principalement dans le réseau universitaire québécois mériterait d'être intégrée davantage aux activités de l'association.

C'est que ces deux groupes linguistiques ont évolué, sur les plans universitaire et institutionnel, dans des milieux relativement clos où les collaborations furent limitées.

Pourtant, l'étude savante de la communauté juive canadienne a avantage à approfondir une compréhension du contexte propre au Canada français, comme à Montréal se sont écrits les plus grands chapitres de l'histoire juive canadienne.

En ce sens l'appoint technique des chercheurs francophones est vital. Inversement, les Canadiens français gagnent à observer l'histoire du Québec à travers le regard d'une communauté étrangère, ce qui est rendu possible grâce à un large corpus de sources documentaires en langue yiddish, dont bon nombre sont jusqu'à présent demeurées inexploitées.

Plus encore, et malgré certaines tensions historiques entre les deux groupes, on observe en filigrane des parallèles qui constituent des amorces de recherche fascinantes.

En effet, la notion de survivance culturelle véhiculée chez les Canadiens français du Québec - exprimée durant la première moitié du XXe siècle par le vecteur du catholicisme et à partir des années soixante par la langue française - ne trouve-t-elle pas un écho chez l'expérience des Juifs canadiens, dont une majorité de descendances ashkénazes s'est longtemps attachée au yiddish comme langue vernaculaire? Dans le cadre de l'histoire moderne du Québec, la proximité de deux populations ouvrières en compétition sur l'échelle socioéconomique, partageant dans l'axe de la rue Saint-Laurent à Montréal un même espace, n'offret-elle pas un portrait frappant de la diversité culturelle de l'entre-guerre au Canada?

C'est donc avec grand enthousiasme que j'entrepris de disséminer les activités de l'association auprès de nos consœurs et confrères du réseau universitaire francophone canadien, dans l'espoir d'inspirer une nouvelle génération à saisir une opportunité unique d'avancer un champ d'études marqué depuis peu par un dynamisme renouvelé.

D'abord il était nécessaire d'incorporer plus de contenu francophone au bulletin, et à ces fins j'ai traduit plusieurs en-têtes et sections dans la présente édition. Ensuite, j'ai dressé une liste exhaustive de contacts des divers départements au sein de facultés d'arts et de sciences sociales et humaines dans les universités francophones à l'échelle canadienne, et à présent l'association s'assurera de leur faire parvenir ses appels à communications

Inversement, les Canadiens français gagnent à observer l'histoire du Québec à travers le regard d'une communauté étrangère, ce qui est rendu possible grâce à un large corpus de sources documentaires en langue yiddish...

pour le journal ainsi que la conférence annuelle.

Ces modestes initiatives, je l'espère, contribueront à favoriser les échanges entre les deux communautés linguistiques universitaires du pays dans le champ des études juives canadiennes.










History of the Garment Trade in Winnipeg," and other exhibitions will be added. A searchable comprehensive database of newspaper article listings (back to 1913), documents, photographs, and artifacts will soon be added.

Switzer-Cooperstock Essay Prize

November 2015. "BESA: The Albanian Code of Honour." An exhibit of photographs and texts discussing Albanian Muslims who saved Jews during the Holocaust. Exhibit held at the Mennonite Heritage Gallery (Canadian Mennonite University). The exhibit is on loan from Yad Vashem.

October 2015 - January 2016. National Council of Jewish Women, 90th anniversary. Jointly with NCJW.

September 2015-January 2016. "Free Discussion is the Key to Peace: The Political Cartoons of Avrom Yanovsky." Yanovsky was a Winnipeg-raised artist who drafted political cartoons for leftist outlets, primarily in Toronto. Jointly with the United Jewish Peoples Order.

June 15, 2015. "The Jewish Foundation of Manitoba, 50 Years." Jointly with the JFM .

November 3, 2015. "BESA: The Albanian Code of Honour." Opening.

October 29, 2015. "After the AMIA Bombing." Talk by Cynthia Fidel, formerly of IWO (YIVO), Buenos Aires. She showed a short Argentinean documentary on the recovery of books and documents from the bombed-out library, showing the devotion of local and international youth, who entered the bombed building and carried out more than 75,000 items and undertook conservation. Ms. Fidel, a recent immigrant to Winnipeg, told about the project that she had worked on in the schools to teach about these events, and she showed some of the books of drawings and texts that the children produced.

October 15. "National Council of Jewish Women, 90th Anniversary." Opening.

September 17. "Free Discussion is the Key to Peace: The Political Cartoons of Avrom Yanovsky." Opening. Talks by Ester Reiter (York University) and Anna Yanovsky. Performance by the North End Folk Choir.

May 12, 2015. The 14th Annual Holocaust Symposium: Survivor Eva Kuper, now of Montreal, spoke on "Women in the Shoah" to approximately 1,300 Manitoba school children.

April 19, 2015. The 10th Annual Sol and Florence Distinguished Lecture presented Art Shavit, Israeli journalist and author of *My Promised Land*.

April 12, 2015. Shoah. Interfaith Commemorative Service with talks by 13 Jews and Christians. Held at St. John's Cathedral (Anglican).

Genealogy: Our database now contains burial records for approximately 20,000 individuals and is up to date to December 31, 2014. It includes the Hebrew Cemetery in Regina, the Thunder Bay Jewish Cemetery, and all Jewish cemeteries in Manitoba. We now include Jewish burials outside of

Jewish cemeteries. Our gravestone photographs are up to date as of the summer of 2010 and number over 19,000.

February 15, 2016. Opening of a major exhibition on the history of synagogues in Manitoba (tentative date).

March 17, 2016. Annual Holocaust symposium for the schools. Speaker: Pinchas Gutter. Survivor of the Warsaw Ghetto and six concentration camps, Mr. Gutter now lives in Toronto.

Death of Norman Vickar (age 98). Norm Vickar was a remarkable man whose life illustrates distinctive features of Jewish life on the Prairies. He grew up on a Saskatchewan farm in a family that came from Lithuania via SouthAfrica. Hebecamean automobile and agricultural implements dealer, Mayor of Melfort, and Minister of Commerce and Industry in the Blakeney government. In retirement, Norm moved to Winnipeg to be close to his children, grandchildren and great-grandchildren and continued his very active participation in Jewish and civic organizations. He served on the board of the Jewish Historical Society (now the Jewish Heritage Centre), including a term as vice-president. He is survived by his wife of 68 years, Florence Zeitlin Vickar, who grew up in Kiev, immigrated to Lipton and settled in Winnipeg before marrying and returning to Saskatchewan with Norman.

Norm Vickar left papers to the JHC Archive, and the family had a 110-minute film, produced professionally, showing Norman's and Florence's life. The film can be viewed at the JHC Archive.

On May 23-25, 2016, the Israel and Golda Koschitzky Centre for Jewish Studies will host a symposium entitled "Paris in Post-War Jewish Literary Memory." The symposium will focus closely on the place of Paris in the prose of five authors: Henri Raczymow (Un cri sans voix), Sara Kofman (Rue Ordener, rue Labat), Patrick Modiano (Dora Bruder), Irene Nemirofsky (Suite française), and Georges Perec (W, ou le souvenir d'enfance).

Our Jewish Veterans: Remembering Those Who Served



Every Remembrance Day, congregations and communities across Canada and around the world recite the names of war veterans, mostly of those who gave their lives in service to their country. As one listens to the names, one wonders who these men and women were and thinks about the choices they made to leave behind families, homes and jobs. This question is the inspiration behind an exhibit on the Jewish war veterans from Saint John, New Brunswick.

Almost ninety men and women from the Saint John Jewish community enlisted in all branches of the services for World Wars I and II - Army, Air Force, Navy, Reserves, Canadian Women's Army Corps and the Canadian Red Cross, and unlike most communities, almost all returned. Only one member of the Saint John Jewish community is buried in a military cemetery in England.

This exhibit is still very much a work in progress. Over the past year, photographs have been collected and scanned, and many conversations have taken place with family members, all

with the goal of learning as much as possible. With the passage of one or more generations, the gathering of information can be challenging, but each anecdote, photograph, document and artifact adds another page to the stories shared in this exhibit.

During most of 2015, we compiled and edited lists of war veterans, read and copied old newspapers and archival documents, collected information from the Internet and books, sent and received emails and messages from family members, and sorted through many photographs. To date, much has been learned about many individuals in the community, and there is much more to discover (it seems we learn something new every day). The search for and verification of information and the interviewing of family members will continue through the coming months.

We were able to share a first draft of the exhibit, ready to mark this Remembrance Day, including photographs, artifacts and a few pages about individual veterans and their stories. The biographical binder, which is the centrepoint of the exhibit, is dedicated to the memory of Garfield T. Meltzer, an RCAF veteran and the founding commander of Atlantic Post #4, Jewish War Veterans of Canada.

During the Second World War, it was not unusual for siblings to serve, including Edward, William, Gar and Lillian Meltzer, Maurice and Hyman Elman, and Nathan and Louis Green, but the Boyaner family sent sons to the First and Second World Wars.

Harry Boyaner was one of five men from the Saint John Jewish community who enlisted to fight in the First World War. He was registered for general service in February 1918 and was part of the Royal Flying Corps from May to December 1918. After the

war he continued his optometry career in western Canada.

His brother. Major Frank Boyaner, was in uniform as part of the Non-Permanent Active Militia



before the declaration of the Second World War, in September 1939. He served as a member of the Canadian Dental Corps in Canada and overseas in England, Malta, Sicily and Italy.

Throughout his service he sent letters home to family members. A letter dated October 31, 1940, described his being presented to His Majesty King George VI and meeting



a heroic Canadian pilot serving with the RAF. Sadly, Frank Boyaner did not return from his service and was buried in Brookwood Cemetery in Surrey, England, in January 1945.

ACJS ANNUAL GENERAL MEETING, JUNE 1, 2015 UNIVERSITY OF OTTAWA

The meeting was called to order at 9:30 a.m., Eastern Time.

CALL TO ORDER AND APPROVAL OF MINUTES OF PREVIOUS MEETING: BARRY STIEFEL

The 2014 Annual General Meeting minutes were approved as published in the Spring 2015 Bulletin. On a motion by Hernan Tesler-Mabé and seconded by Barry, the motion passed.

ANNUAL REPORTS

a. President's Report- Barry Stiefel

Barry read the following report:

"This has been my first year as president of the ACJS, where I took on the role at our 2014 annual conference at Brock University in St. Catharines, Ontario. Over the past year I have attempted to plant some seeds that will hopefully benefit the organization over the coming years. The first, which will have a session at our upcoming conference in Ottawa, is an Educators' Roundtable. The purpose of the Educators' Roundtable is to create a forum for improving the quantity and quality of Canadian Jewish studies subjects taught at the primary, secondary and university levels; strengthen the Canadian Jewish studies field by better understanding the opportunities of Canadian Jewish studies skills in the job market; and establishing a means for Canadian Jewish studies educators across the country and at all levels (from the teaching of children, to higher education, to senior continuing education) to be in conversation with one another. Professor Ira Robinson of Concordia University will moderate this as our new Academic Committee Chair. I believe that through self-reflection and dialogue in the way we conduct Canadian Jewish studies education, we can do a better job of it.

Another seed, which will hopefully bear fruit with the involvement of everyone, was a survey for institutional improvement designed by Allie Cuperfain, SJ Kerr-Lapsley, and me. Many of you participated in this survey August-October 2014. SJ Kerr-Lapsley has recently compiled a report of results from the survey, which we will discuss later this meeting."

The report was received and accepted, without comment.

b. Treasurer's Report – Janice Rosen on behalf of Emily Lam

Janice circulated copies of the report to all, along with the proposed budget for 2015-2016. In summary, Emily's report showed an increase in revenue from membership and donations, but also increased expenses from the cost of desktop publishing for the Bulletin as well as from the number of paper copies requested by members. Congress (CFHSS) membership fees have increased due to an annual 1% raise in their cost per delegate fee. The full report can be seen in Appendix 1.

Discussion: Rebecca Margolis noted the lack of growth in the area of investments.

After it was noted that the proposed

budget included a deficit of over \$2,000, a discussion ensued about how to reduce the deficit in subsequent years. The ideas put forward included:

Barry: We should economize – coordinate by committees.

Rebecca: Part of the reason we are short of funds is that our investments have not been growing at all. We should elect Frank Bialystok as Finance Chair and have him handle this aspect, because he has the expertise to invest the association's funds wisely.

Barry and others approved of this idea.

Gary Davis proposed a focus on increasing memberships and suggested that we bring in more associated society members, who are not academically affiliated, at a lower rate.

Regarding the proposed budget, it was noted by David Koffman that the amount budgeted for the Journal was incorrect by \$1,500, as that amount was being provided via a grant from York University's LA&PS Support for Scholarly Journals fund in the coming year, thus reducing the amount required from ACJS and reducing the projected deficit. Noting that the Journal is now available online, David suggested the possibility of allowing members to opt out of receiving the paper version of the publication in order to be members at a reduced rate, but then countered this idea by speculating that the savings from printing only a few Journals on demand would probably be insignificant, as the current number of printed journals is already a minimal order.

Rebecca – Rather than cutting back we should be expanding our activities and finding a way to fund them. We need to offer more activities and assets; the price is not the issue. We need to get back to our grassroots, as we are losing touch with our members. She suggested reaching out through archives and historical societies.

Agi Romer Segal (Calgary) noted that these groups were becoming more active now in some of the outlying regions. She suggested that ACJS could subsidize scholars from the centre of the country to come out to other regions to give a lecture.

David suggested that Barry draw up a list of these "value-added" suggestions: selling "swag" items such as Society T-shirts; reaching out to grassroots; increasing investment portfolio; more student engagement (promoting ACJS to younger scholars); and creating a speakers' bureau.

Richard Menkis noted that AJS maintains a speakers' bureau – a list of scholars could be provided to our affiliate organizations (those who pay the \$180 membership), and they would get a free lecture if a scholar would already be somewhere near that area.

Re: promoting ACJS to students, Stephanie Schwartz noted that students receive great benefit from participation in the Annual Conference; developing skills in speaking, adding to their CVs and the possibility of being published. Hernan Teslar-Mabé noted that students should be further encouraged to write papers. David commented that he had made an arrangement for some student papers from his classes to be published on the Ontario Jewish Archives website.

Barry raised the idea of using LinkedIn for Society promotion. Stephanie noted that one-on-one, face-to-face contact was most effective. Hernan added that direct digital contact could work as well.

Peter Usher raised the question of membership advantages for nonacademics: What happens locally?

Ira Robinson noted that Jewish historical societies no longer exist in Montreal or Toronto and should perhaps be encouraged again; others noted that the Jewish genealogical societies in these cities had taken on this role. Frank Bialystok noted that we needed to engage local communities more with the conference.

Simon-Pierre Lacasse noted the importance of using social media for relating the Jewish experience to other shared experiences. An updated website would help in this approach and suggesting showing local neighborhood sites in the past and present.

Rebecca countered that this type of development on the website would require Committee member involvement, as the present website administrator could only commit to a few hours of work on an occasional basis.

Before voting on the proposed budget, David Koffman reminded those present that the total amount budgeted for the Journal should be reduced by \$1,500, due to the York University grant.

Rebecca raised the question as to whether changes could be made to the budget in the course of the year; Barry said yes, after a discussion with the president and treasurer.

There was a motion to accept the 2015 Treasurer's Report and proposed budget for 2016, as well as the proposed budget, with the understanding that a correction to the projected journal expense total would be made.

Ira moved to receive the report as presented. Frank seconded, and the motion was approved.

There was a motion to re-appoint Silver & Goren as auditors for the 2015 fiscal year.

The motion was moved by Janice, seconded by Randal, and approved.

c. Secretary's Report - Janice Rosen

Janice reported on her last year as Secretary, thanking Ira for the assistance and assistants provided through his department, and expressing hope for a smooth transition to the new secretary, with the help of access to remote technology. She noted that more coordination with regard to membership information was important.

d. Bulletin Report-Sarah Jane (SJ) Kerr-Lapsley

Sarah Jane reported: "My heartfelt thanks go to Shirley Muhlstock Brodt, Susan Landau-Chark, Randal Schnoor and Barry Stiefel for their patience and assistance as I transitioned into this role. Though I struggled to balance the bulletin's timing with my coursework - negotiating deadlines that fell during midterms and finals - both the fall 2014 and spring 2015 bulletins came together smoothly thanks to Shirley's hard work and dedication and Randal and Barry's support and assistance. Many thanks as well to Georgia and Lillooet for printing and uploading the bulletin and to each and every ACJS member who contributed their news and updates and offered their assistance.

I am stepping down with the hope that I will be selected to coordinate next year's conference in Calgary, and I recommend Rebecca Margolis for the position of Bulletin Editor."

e. Journal Report (David Koffman and Stephanie Schwartz, co-editors)

David and Stephanie reported: "Canadian Jewish Studies has had an extraordinary academic year, 2014-2015. The journal published two special volumes, one dated 2013 and the second 2014, putting the journal back on track to publish annually, with the volume published in the same calendar, membership and production year, beginning later in 2015. We remain in good financial standing and have taken steps to increase the reach of the journal, its attractiveness, and its breadth of relevant content... The journal remains on schedule for the publication of Volume 23 in the summer or fall of 2015.

The co-editors are pleased to report the solidification of a regular sub-section of the journal entitled "The Archives Matter," in which a consortium of archivists working across Canada's Jewish archives selects a theme, curates artifacts, and writes short pieces that showcase Canadian Jewish archival holdings and their relevance to the mission of the ACJS, ensuring a geographically balanced presentation of materials.

We are equally pleased to announce the inclusion of a new, additional special regular sub-section to the journal devoted to "Translation," scheduled to begin with Vol. 23.

Recognizing the importance of translation and of the multilingual nature of the Canadian Jewish experience, the co-editors have established a consortium of translators, who will work together to select texts of scholarly interest to Canadian Jewish life from a language other than French or English (Arabic, Farsi, Hebrew, Russian, Yiddish, etc.) to be included in the journal in translation in every issue.

We are pleased to announce that the journal was awarded a grant for 2015-2017 from York University for \$1,500 to help cover the costs of copy editing, translation, web and design improvements.

We have retained a new layout editor who has made several aesthetic changes to the cover, colours, font and format of our printed (and PDF) pages, all of which we believe is to the benefit of the ACJS. (Graduate student) Elizabeth Moorhouse-Stein, who assisted with volume 21, will be staying on as a production assistant for volume 22.

We would also like to thank Pierre Anctil and Vivian Felsen, who have agreed to spearhead our new translation section."

f. Membership Report – Barry Stiefel for Seven Lapidus, Membership Chair

Based on the latest figures available before the conference, Steven reported that there are 89 paid-up members for 2015, an increase of 44 since 2014.

g. Conference Report – (Rebecca Margolis)

Rebecca reported:

"Planning for this year's conference has gone very smoothly. The online

system now works very well, which makes the technical side of things much easier. Everyone registered for the Congress on time, and there have been very few cancellations (only two). This year brings in many new faces, which is exciting, including a number of panels in French. In this spirit, we have translated our acceptance letter and program into French so that they are bilingual. I recommend broadening this venture by doing more active outreach to more colleagues doing work in Canadian Jewish studies and in comparative fields in both English and French. I will be stepping down as Chair and recommend that Sarah Jane Kerr-Lapsley fill the position, with me working with her as needed in the transition and bequeathing her with all of my spreadsheets, form letter and other files."

h. Archives Report – Barry Stiefel for Dara Solomon, Archives Committee Chair

Dara's report highlighting cooperative and other notable efforts recently undertaken by Canadian Jewish Archives was summarized by Barry, who noted in particular: "The Archives Committee came together in 2013 to create a section in the Canadian Jewish Studies Journal called "The Archives Matter," and have published two issues so far, highlighting various topics related to the Canadian Jewish archives community. Members from the Archives Committee will also present Outside the (Archival) Box: Bringing Canadian Jewish History to the Public at this year's ACJS annual conference in Ottawa."

Barry summarized Robin's report that described how, following the implementation of various revisions by Robin, the website was now managed by a contracted assistant, Lillian Nordlinger.
